

CRW Consulting Firearm Training Waiver and Release of Liability

IMPORTANT: READ CAREFULLY BEFORE SIGNING

This is a legally binding waiver and release of liability made by the undersigned participant ("Participant") in favor of CRW Consulting ("Company"), its instructors, staff, agents, and employees (collectively, "Released Parties"). By signing this document, the Participant acknowledges and agrees to the terms and conditions herein.

1. Acknowledgment of Risks

Participant acknowledges that the use of firearms and participation in firearm training involves inherent risks, including but not limited to:

- Bodily injury (including severe injury or death)
- Property damage
- Hearing damage
- Psychological impact (such as stress or trauma)
- Accidental discharge of firearms
- Negligence of other participants or third parties

The Participant acknowledges that these risks may result from the actions or inactions of themselves, others, or the condition of the premises or equipment used.

2. Voluntary Participation

The Participant affirms that they are voluntarily participating in the firearm training provided by the Company. They are aware of the risks and hazards associated with firearms and voluntarily assume all risks of injury, harm, or loss arising from such activities.

3. Waiver and Release

To the fullest extent permitted by law, the Participant agrees to release, discharge, and hold harmless CRW Consulting and the Released Parties from any and all claims, demands, suits, costs, expenses, liabilities, damages, or losses, including but not limited to those for personal injury, death, or property damage, arising from or related to the Participant's participation in the firearm

training, whether caused by the negligence of the Released Parties or otherwise.

4. Indemnification

The Participant agrees to indemnify, defend, and hold harmless CRW Consulting and the Released Parties from any claims, liabilities, damages, costs, or expenses, including reasonable attorneys' fees, resulting from any claim by a third party arising from the Participant's actions during the training.

5. Compliance with Laws and Instructions

Participant agrees to comply with all federal, state, and local laws, regulations, and ordinances while participating in the training, as well as the instructions and rules provided by the Company and its instructors.

6. Assumption of Responsibility

The Participant affirms that they are responsible for their own health, safety, and personal property during the training. They agree to bring appropriate equipment, including but not limited to firearms, ammunition, and safety gear, and ensure that such equipment is in good working condition.

7. Medical Condition and Ability

Participant affirms that they are physically and mentally fit to participate in firearm training and that they do not suffer from any condition that would prevent their safe participation. They further agree to immediately notify the Company of any injuries or concerns during the course.

8. No Warranty

CRW Consulting and its instructors make no representations or warranties about the results of the firearm training. The Participant understands that firearm training is a skill-based activity and that success or failure in its application depends on many factors outside the Company's control.

9. Governing Law

This waiver and release shall be governed by and construed in accordance with

the laws of the State of New Mexico, without regard to its conflict of law principles. Any legal action arising out of or related to this waiver shall be filed in the state or federal courts located in New Mexico.

10. Severability

If any provision of this waiver and release is found to be invalid or unenforceable by a court of competent jurisdiction, the remaining provisions shall remain in full force and effect.

11. Understanding of the Agreement

The Participant affirms that they have read this waiver and release and fully understand its terms. They affirm that they are of legal age (18 years or older) and have the legal capacity to sign this document. They sign it freely and voluntarily without any inducement, duress, or coercion.

12. Binding Agreement

This waiver and release shall be binding upon the Participant, their heirs, assigns, personal representatives, and next of kin.
